This one acre lot is located in the southeastern portion of the Rio Grande Estates Subdivision, very near HWY 60. Power is only two lots to the west. Unlike many of the lots in the subdivision that take a 4 X 4 to get to (or have no road at all) this parcel is accessible with a two-wheel drive vehicle and easy to get to over maintained gravel roads (as can be seen in the pictures). Being in Socorro County there are no restrictions.

### Rio Grande Estates Community (Socorro County)

Located just about half way between Belen and the town of Socorro off of I-25 lies Rio Grande Estates, a master-planned subdivision. The area was platted back in the 1960's. Sitting southeast of Belen and only about a 40-minute drive to Albuquerque, this land is perfect for anyone looking to live an "off grid" lifestyle.

Socorro County has no formal zoning ordinance and does not restrict the use of the property within its county. This makes the area ideal for anyone with an RV who's looking for land they can vacation to, camp on, or park and live on for lengthy periods of time without being hassled by local officials. This also makes the area fitting for other types of "unconventional" dwellings such as earth ship homes, tiny homes and shipping container homes. Best of all is that because this entire subdivision was platted into one acre lots, this means the minimum "3/4 of an acre building threshold" will be met by all of the individual lots within this region, allowing owners to both install a well and a conventional septic system on each parcel. This will make the cost of building and living in this region far more affordable than what you'd encounter in other subdivisions whose land does not conform to that standard.

### Belen

With nearly two dozen restaurants, several hotels, a Wal-Mart and many local shops and services, you can find anything you need right in the town of Belen. Located just 30 minutes south of Albuquerque, Belen is the second largest city in Valencia County. Known as the "Hub City" for the railway cutoff of multiple rail lines, Belen is home to nearly 7500 residents.
